GENERAL NATURE OF WORK: This position is under the direction of the Pool Manager. The primary responsibility is to ensure the safety and supervision of swimmers at Wilson Park Pool.

EQUIPMENT & JOB LOCATION: This position requires knowledge of all materials required for life safety, including CPR and life rescue equipment. The primary work site is the Wilson Park Pool, 1226 S Elm Street.

ESSENTIAL FUNCTIONS – EXAMPLES OF DUTIES:

Any one position may not include all of the duties listed, nor do the listed examples include all duties that may be found in all positions in this class.

- Maintain the safety of all at Wilson Park Pool under the guidance of the Pool manager
- Interact with the public, answer questions, and assist patrons while maintaining a professional and courteous relationship with the public
- Actively participate in drowning prevention actions to intercede before an emergency develops
- Respond to and participate in water rescues
- Provide First Aid, Medical attention, and CPR to those in need
- Maintain equipment and supplies in good working condition and report any issues
- Participate during in-service training
- Maintains pool area, including garbage and debris removal
- Performs other duties as required under the direction of the Pool Manager
- Be Alert

ADDITIONAL EXAMPLES OF WORK PERFORMED:

- Enforces Wilson Park Pool Rules
- Assist in swimming instructions and other aquatic activities

- Ability to swim and dive proficiently
